lowa Code Chapter 22.7(50) states that information and records concerning security are confidential "if disclosure could reasonably be expected to jeopardize such life or property." Subparagraph (a) goes on to state that information is confidential if its disclosure "would significantly increase the vulnerability of critical physical systems or infrastructure to attack."

Disclosing the dates on which State Treasurer Smith entered the capitol would not jeopardize any life or property. lowans reasonably expect the treasurer to come to work on a regular basis. I was not seeking any passwords or security codes that could endanger state property or the treasurer's safety.

To make it more clear that I am not seeking any dangerous information, I ask that DAS redact the times that Treasurer Smith carded in and out of the state capitol. I am seeking only the dates on which he entered the building from January 2, 2023 to the present. A reasonable person would agree that information can be extracted from the key card without jeopardizing anyone's life or property.

Thank you for your prompt consideration of this request.

Finally, I am seeking an explanation from DAS as to why it took you more than three months to respond to my initial request.

Under Iowa Code Chapter 22 I request the following public records:

- 1. Records showing dates on which State Treasurer Roby Smith has used his key card to enter his office in Des Moines, from January 2, 2023 to the present.
- 2. Copies of mileage reimbursement requests submitted by Treasurer Roby Smith (or by staff on his behalf) from January 2, 2023 to the present.

To be clear, I am asking for all such records in the possession of the Department of Administrative Services, whether the original request for a mileage reimbursement was submitted to DAS or to another state entity, including but not limited to IPERS or the Lottery authority.

3. Records showing payments to Treasurer Roby Smith for mileage reimbursements from January 2, 2023 to the present.

I request that these records be provided in electronic format and sent to me via email.
